

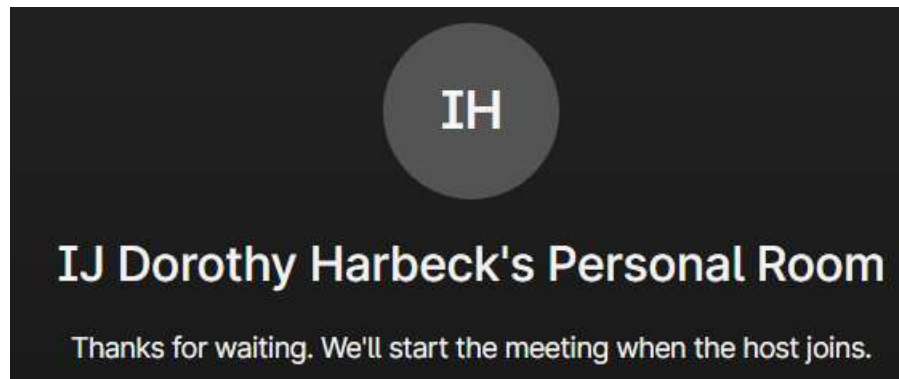
For your “Display Name (required)” you may choose to put your first name for Toaquiza587 [e.g. Kelly for Toaquiza587], so that anyone in the WebEx can see that you are an individual supporting Alex **UNCHECK “Remember Me” so that you can put in another name at future hearings!** – Kelly will post in the chat (that the Judge sees, too) a request that the Judge inform Alex of the community support present for whatever decision Alex makes with regard to his case. **2 weeks earlier, the other judge noted that there were many “Friends of the Court” present at the hearing.**

During the preview before entering the meeting, **please mute** your microphone; you may also turn off your camera.

To attend via telephone, please text Kelly at (916) 877-5947 that you are entering the call – it is probable that the last 2 digits of your phone number will be displayed because the Judge asked who was entering with last digits 47 when Kelly did her test, **then copy** the following number to get you through the prompts (or 10 digits after +1- and follow the prompts yourself).

Note: For the last several hearings, Kelly on her laptop, and several others using SmartPhones, were invited to leave a message indicating we were waiting – during a test on Friday with this Judge, the following message appeared:



In prior hearings, several individuals used SmartPhones, one of whom could get no sound, but appeared as a “participant [Friend of the Court]” that achieved our objective of demonstrating our support for the immigrants.

For this hearing, the first time Kelly tried to use a SmartPhone rather than a laptop, her \$30 Android SmartPhone compatible with TracFone couldn’t download the current version of the App, nor could she access the WebEx via browser (BUT, she was able to call!)
