President's Message Robert South

At our July meeting, the Board realized that we had too many issues to address in the normal board meeting format, which is typically under an hour and mainly focused on what is going on and how to delegate handling it. So, rather than spread the work over several meetings with homework assignments in between, we decided to have a long "Board Retreat" like the ones we had been doing about every other year before COVID.

On August 24th the board spent about 4 hours alone in a room together physically and hashed everything out. The first issue was to address the mandate from the congregation to compose goals for the upcoming fiscal year. We agreed that the annual goals should be in line with the long-term plan, but decided our long-term plan just boils down to our Mission. Then we devised our three-item plan for the next fiscal year. We are calling a formal meeting of the congregation after the worship service on September 29th. We will present this with the exact wording, but here are the three main themes for the year:

- 1. <u>Stabilizing the Building</u> by addressing the current issues and what is needed for the future by hiring an inspector who will give us advice on what steps to take,
- 2. <u>Searching for a Half Time Minister</u> with a revised offer of \$36000, plus social security taxes, and up to \$5000 for moving expenses, and
- 3. Committing to Community Outreach and Social Action at the direction of the congregation.

We generally all agreed that what we mainly need from a minister is not so much sermons but the kind of counseling and ministerial services that require a certain amount of physical presence among us.

We dissolved the Building and Grounds committee. The consensus was that it has long not really functioned as a committee. As we often have operated in the past, the board will address building and grounds related matters directly, delegating individual issues and problems to appointed task forces and ad hoc committees. For instance, an ad hoc committee will be seeking estimates for our snow plowing contract. Robert South will be the point of contact for housekeeping issues inside the building, Kelly Sackheim will be the point of contact for groundskeeping issues outside the building.

We will also present a minor bylaw change at the September 29th Congregational Meeting. We are adding a provision that authorizes members who opt into it to be sent notice of Congregational Meetings by email. Currently the bylaws call for this to be done by postal mail, which is why the post cards you get every year.

Separately, the Religious Exploration Committee will be meeting on September 1st to set up the wondering center nicely and to prepare one off "lesson boxes" for volunteer teachers and assistants to use if children come to visit. We will also consider the idea of moving the actual lesson portion of RE to occur during social hour rather than during the service. We will offer formal RE only to children ages 4 to 12. During the service, children can engage in supervised play in an adjacent room or stay with their parents.

Covenant

The Board of Trustees adopted a covenant about 20 years ago, but it had fallen out of use by 2012. During the COVID era the board revived it and has been beginning every meeting with it. During our recent retreat, we revised our covenant and also agreed that the congregation should know about it. So here is our revised covenant:

Board of Trustees Covenant

In working together to serve All Souls UU Church we covenant:

- (1) We will work toward the mission of the church.
- (2) We will treat each other with respect by each practicing the following
 - (a) I will actively listen to the speaker who has the floor.
 - (b) I will minimize side comments.
 - (c) I will focus on issues and not personalities.
 - (d) I will maintain appropriate confidentiality.
 - (e) I will promptly respond to other Board member requests, whether face to face, voice mail, or email.
- (3) We will be honest and direct with each other in the following ways.
 - (a) I will speak out when something is of serious concern.
 - (b) When I have a suspicion, concern, or question, rather than make accusations, I will ask questions.
 - (c) I will work to resolve an issue directly with the involved person(s) and will support and encourage others to do the same.
- (4) We will be responsive to the congregation and encourage members and friends to communicate with the committees when appropriate.
- (5) We will speak with one voice on church policies and procedures.
- (6) We will focus on policy issues in compliance with our church bylaws and policies.
- (7) During Board meetings we will focus on the agenda.



Social Justice Survey Alabama Dane

Social justice holds an important place at the heart of Unitarian Universalism. It aligns with the UUA principles and our own goals as individuals who want to live in a world where all people and all peoples can live peaceful and fulfilling lives without facing lack of resources or injustices.

The ASUU board would like to ask for input and direction from you - the members and friends of our congregation. We will explore social justice and how actively working to better our community can benefit our neighbors, ourselves, and our congregation in the September 22nd service.

Please be prepared to share your ideas regarding the needs and injustices our community faces, as well as actions we can take and/or groups we can partner with to accomplish these goals. Following the service, you can expect to see further requests for your input regarding potential social justice initiatives. Additional ideas will be collected, and final decisions will be made, by anonymous online surveys.



A Note from Our Treasurer Eleanor Allen

We don't usually include financial statements in our monthly newsletter, mainly because by the time they get into the newsletter, they'd be several months old, but the June report shows the figures for the entire fiscal year, so I think it's appropriate to include it, especially this year when we'll be talking about our finances at the meeting on September 29th.

Since our fiscal year runs from July 1 through June 30th, the June financial reports, which are prepared for the July board meeting, shows what we've received and spent during the entire fiscal year. This year's report shows that even though we didn't receive every penny promised in pledges, we received more than we had budgeted in donations, building use income, and interest income, so our total income exceeded the budgeted amount by 7% even though we held no fund raisers this past fiscal year. Our overall expenses for the year were considerably less than budgeted, mainly because all expenses for building repairs and maintenance came out of the insurance funds, as a pass through expense, instead of being taken from our regular budget.

The Balance Sheet shows our total assets as of June 30th, 2024. The money bequeathed to us by the Owens family is held at UBS in two separate accounts, the Capital Growth Fund and the Owens Fund, and currently totals \$530,740. We cannot spend that principal, but during the past fiscal year, used \$1,800 each month, from the income generated to help meet our expenses.

I keep forgetting to ask others about Megan O'Meara. She has been making a modest monthly PayPal donation to us each month for a few years. If we are not set up to grant her an indulgence, we should at least thank her. Does anyone know her address?? Many decades ago the comedian Jimmy Durante ended each radio broadcast by saying "and good night to Mrs Cala-bash wherever you are." Should we close each service by saying "goodnight to Megan O'Meara wherever you are"?

Here's an update on our congregation's income for this new fiscal year. Thus far 25 of us have pledged \$35,495, plus one of us has pledged funds towards our electric bill. Of that \$35,495, some have been able to cover theirs all at once, and as of August 30 towards this year's pledges we have received \$12,300. Also, loose coins and paper money put into the plates for our Generosity Project is \$321 already; and \$36.01 towards our free-trade coffee; and \$665 in donations for our own miscellaneous expenses; and \$85 in rent donations. Also, since July 1 we have received \$600 towards some pledges made for our prior fiscal year which ended last June. It all helps to cover our common bills, and thank you for your help.

Now my next chore is to work on the report on our good use of the grant from the NYS Universalists for \$3200, some of which was put to work in the underwriting of an "ad" on NCPR on Fridays between 5 and 6, for us and for the UU Fellowship in Plattsburgh. ~~Warren Allen

Generosity Project

Every year we choose two organizations to share half of our uncommitted plate collections. It works as follows: the collector tracks the uncommitted funds, and the congregation selects the organizations. At the end of the church year, we divide the uncommitted funds in half, retain one half, divide the remainder in half and send those monies to the chosen organizations. This year we chose Citizens Advocates and Zoo New York. Each organization receives 1/4 of the uncommitted funds for the year.
