From the President's Desk

Robert South President's Report

This month a team has been working on the memorial garden and another team have been gathering bids for work on the building. Thanks to Kat, Amy, Janine, and Kelly. Contractors were uninterested in responding to the Request for Proposal, so we are getting traditional estimates, which turn into quotes (or bids if competitive), which become contracts when signed. Instead of (expensively) all meeting exact specifications as phrased by the architect, we are asking each contractor to tell us how they would solve our situation



and how much it would cost--with options offered for different paths. We learn more that way. For instance, a contractor told me this morning that board and batten vinyl siding only comes in 10 foot lengths (at least off the shelf from Whites) so we would have horizontal "J channels" every 10 feet if we went that way instead of the traditional "dutch lap" siding you see on houses.

In my hat as office manager, I've almost got the annual report ready as of this writing. And in my hat as president, I enforce the bylaws and I'm telling you a plan of the nominating committee (to nominate someone to fill the remainder of a term of a trustee being promoted to officer) won't wash. The bylaws call for 2 trustees to be elected to two-year terms at every annual meeting. Empty seats are specified to be filled by decision of the board. Trustees can resign after one year if they don't want to do the full term, but can't be elected to one-year terms. The congregation itself can't change that without a bylaw amendment. The congregation can resolve an "interpretation" of the bylaws, but can't outright violate them.

Collectorland Warren Allen

Thank you for your generous gifts of your time, and for your dollars which help to pay for our group's bills. For our current 2024-25 Fiscal Year, 27 pledgers set goals totaling \$35,497. Others of us donate what we can, without a pledge card. As of May 18, pledge payments received total \$31,972 or 90%, with six weeks left in this FY.

Also, during this year almost gone some of us have brought in (through May 18) unpledged donation checks totaling \$3,659. Also, we have brought to our collection plates loose cash thus far totaling \$2,252 for our Generosity Project, which we split with one half of this towards our own expenses, and one quarter to each of the other two charities for which we voted last June ~~ Citizens Advocates and Zoo New York.

Also, we have thus far received \$78 towards the Free Trade coffee which we use, plus rent donations of \$1148 from friends at the AA and the t'ai chi classes. (You may not know that our members can take these great t'ai chi classes here without charge!)

But wait: there's more. A few years ago, we had a building fund campaign, installing lovely cedar siding. But then some of those boards became loose on one or both edges. As far as I know, those carpenters used staples which were too short. Rebecca kindly covered one area with a tarp, and then Robert kindly installed a few screws in about every board on the outside of our building, and no more boards fell off. We are discussing plans for this now. Thus far, some of us have donated another \$520 for these building fixes, with much of this generously given by folks in two groups which are currently meeting in our building.

For the coming 2025-26 Fiscal Year, as of May 18, twenty-one of us have pledged \$35,920, plus an additional \$5,470 for the building fixes. Together, we can do so much. Thanks!



Historian Sarah O'Connell

It's Throwback time! I found this article in the summer 2015 newsletter, and thought it was worth repeating!

Another tidbit from the Looking Backwards column in the Watertown Daily Times from 1890 spoke about the Demorest medal contest being "repeated" (by request) on Friday evening, May 2. This the Women's Christian Temperance Union, with the cheerful acquiescence of the seven contestants, has undertaken to do, that this branch of temperance effort may be more thoroughly understood and entered into in this city." Not being familiar with this particular event, I had to look up what the Demorest medal was. This, according to an article on the Harvard.edu website: "The Demorest prize was created by

philanthropist W. Jennings Demorest (1822-1895) in 1886 to encourage young people to recite speeches of temperance movement leaders. Its medals—silver, as here, gold, and even diamond—were presented in contests throughout the country through the early years of the 20th century." So, if you run across a silver medal on a ribbon in a drawer or jewelry box that says "Demorest Prohibition Prize," you'll know what it's for!

Generosity Project

Every year we choose two organizations to share half of our uncommitted plate collections. It works as follows: the collector tracks the uncommitted funds, and the congregation selects the organizations. At the end of the church year, we divide the uncommitted funds in half, retain one half, divide the remainder in half and send those monies to the chosen organizations. This year

we chose Citizens Advocates and Planned Parenthood. Each organization receives 1/4 of the uncommitted funds for the year.

A Guide to Annual Meetings

Be Prepared, be Kind

Many congregations are having annual meetings in the coming weeks.

Those meetings will include some 'state of the congregation' reports, some mission and vision celebrations, recognition of leaders and projects and maybe some transitions. Sometimes there will be policy changes or a bylaw amendment. Usually, there will be an election of officers. And, those meetings include budget approvals.



Those budgets usually have been reviewed in open board meetings and sometimes special budget town halls. Sometimes more than one.

WHY?

Because those board meetings and town halls are when when discussion and explanation and reasoned debate can happen, in preparation for the annual meeting.

WHY?

Because annual meetings are already long and sometimes tedious, especially if there are questions about policy or bylaw changes, or if there's a lot of news to share (for example, if there's a building project or a major personnel shift). And honestly, most people do not care about the fiddly points of the budget, as long as the lights stay on, staff get paid fairly, and programs are supported.

- The Annual Meeting is NOT the time to renegotiate the minister's salary, or to suggest maybe we don't need a minister.
- The Annual Meeting is NOT the time to go through and decrease by nickels and dimes the programs you don't like in order to give a few hundred more to the one you do like.
- The Annual Meeting is NOT the time to bring your quibbles about how much (if anything) we give to the UUA's Annual Program Fund (formerly Fair Share), to support the work of the Association.
- The Annual Meeting is NOT the time to suddenly freak out about spending a dime on programs because you personally had a rough year.
- The Annual Meeting is NOT the one time of the year you should show up in the building or any of the events to make your displeasure with the congregation known.
- The Annual Meeting is NOT the time to complain about the budget if you are a non-pledging member.

Instead...

- The Annual Meeting IS the time to come having at least read the budget, and gone to the prep meetings if you cared about that (or not if you trust the people in the room).
- The Annual Meeting IS the time to come having read the other material, or at least have scanned it.
- The Annual Meeting IS the time to engage thoughtfully and respectfully even if there
 is some disagreement.



• The Annual Meeting should be a time of good congregational work and great congregational celebration.

Please do your preparation, and please be kind to one another. It's been a *really long year* on top of a series *of really long years*, and, to quote a ten year old I know who chose to not engage in a fight with his older brother, 'I'm too tired.... it's just not worth it.'
